

## Pioneer Funds Reorganization Into the Victory Funds

In conjunction with the acquisition of Amundi Asset Management US, Inc. by Victory Capital Management Inc., which was completed on April 1, 2025, the Pioneer Funds are being reorganized into the Victory Funds. The reorganization is subject to approval by Pioneer Fund Shareholders. The accompanying table provides a status on those Funds that have completed the approval process and those pending approval. Note: The Fund reorganization does not impact the investment teams managing your Funds or their investment processes and approach.
