Ideas are analyzed within the context of the portfolio's risk profile and our standards for diversification as it relates to sector and industry, emerging versus established growth, and cyclical versus secular growth. Our process seeks to generate superior relative and risk-adjusted (alpha) returns versus the Russell 1000® Growth Index over a full market cycle.

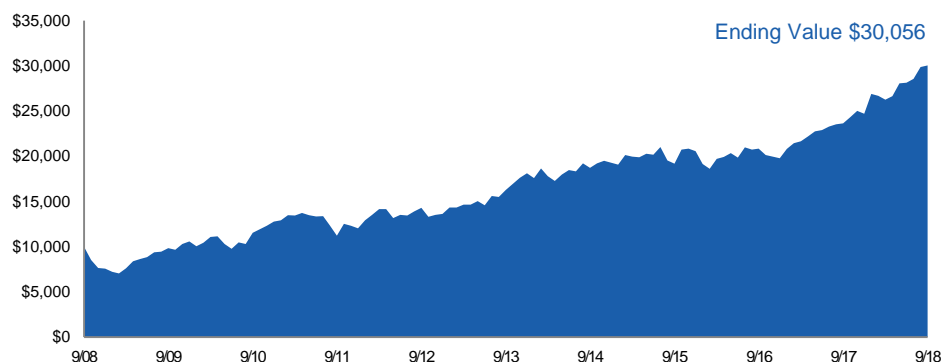

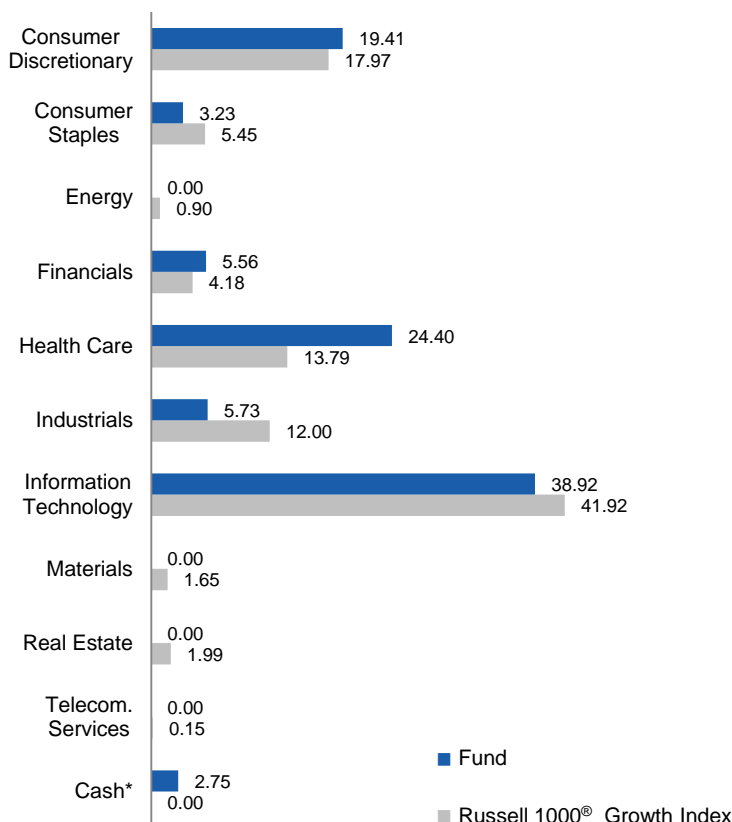

Sharpe ratio is the average return earned in excess of the risk-free rate per unit of volatility or total risk. **R-squared** is a statistical measure that represents the percentage of a fund's or security's movements that can be explained by movements in a benchmark index. **Price-to-earnings ratio (P/E ratio)** is a ratio for valuing a company that measures its current share price relative to its per-share earnings. It represents the multiple of earnings at which a stock sells.

The Russell 1000® Growth Index is a market capitalization-weighted index that measures the performance of Russell 1000® Index companies with higher price-to-book ratios and higher forecasted growth values.
